- III. Financial Report from 2014-2015 Fiscal Year (Christina) "We are in fine financial shape but we did run at a loss last year. Consider expanding membership." It appears that three line items contributed to the loss this year: ~1800 from "revenue events", mostly the Andrew Berry event; ~1800 from community outreach, and ~4100 in new schools committee expenses, consisting of \$1200 for a sparsely attended Western Slope reception and 1800 for Visitas. There is discussion of doing a mailing for members with lapsed memberships to raise funds as well as cutting ~1000 from the budget

- IV. Past events
  - A. Global Networking Night, 22 June (Tracey)
  - 1. Colorado Springs-Mateo Muñoz ran the Colorado Springs event. It was very late getting on the list, but he got about half a dozen people.
  - 2. Denver--The View House attracted about 35 people, many of them new faces. They came from as far afield as South Dakota and Colorado Springs (she knew there was one there but chose to come to Denver because there would be more people).

Although the venue was considerably less expensive than the Chinook has been in the past, it was substantially noisier. There were a lot more people there on a Monday night than the management had anticipated.

Tracey would do it again there, but try to get a more private area while avoiding food/beverage minimum. We need to be sure it is listed as "Denver" rather than "Centennial" in the HAA's publicity. A couple of possible speakers and five new interviewers were identified.

Rex Van Gordon would like to sponsor an event in Boulder in return for modest recognition – possibly the January GNN, possibly something else.

The person who has previously done Fort Collins has moved, so that remains open if we want to do a GNN there.

# A. Annual Meeting / BBQ

We will use John Griffin's community facility again. It is reserved on Sunday, September 13 from 2:00 to 6:00, allowing for a three-hour party with 30-minute setup and cleanup periods. It will cost \$100 for the use of the facility and a \$300 security deposit. Pool use remains to be determined and is likely to result in additional charges. The facility has a 60-person limit; this will need to be managed. Last year, we had an early crowd and a late crowd, and it is unlikely that 60 was exceeded at any point.

Because we ran out of food last year, Tracey will order more per capita this time around. Accordingly, it would be advisable to increase the tariff. Hence:
