I. Prelims

- A. Regrets: Eric

- C. Personal Matters: This is Phil's last SC meeting and Tracey's last meeting as president. Phil looks forward to working a bit less and spending more time with his family. JK just finished his MPH in public health policy.
- D. Consent agenda adopted unanimously.
- II. Consent July minutes (JK): Approved unanimously with no amendments.
- III. Financial Report for July (Christina)
 - A. See emailed reports. There was very little activity this month but a \$350 deposit check was returned this month.

 - 3. Announcements: There will be an announcement on the website this Saturday 8/13. There will be separate emails for recent grads.

VII. Status Updates

- A. Schools Committee (Fred): Sunhee's daughter will probably apply this year. If she applies early and is accepted, then Sunhee might be able to rejoin the committee. If not, she will have to sit this year out. Fred will discuss the contingency with the Admissions Office to ensure its ethical rectitude. Stacy Lyne is going to continue on this committee as well. Sunhee and Stacy are planning to attend the Cambridge Admissions Conference this fall; this may result in a plane ticket's expenditure to support attendance for Stacy.
- B. Membership Committee (Tracey): Many memberships come up for renewal around the annual meeting. There has been discussion of a membership drive but little movement. This discussion, in fact, results in a mini-membership drive where Ed and Andrew renew their memberships.
