I. Call to Order

2. May 4, 2011 Meeting Minutes

3. Treasurer's Report - July 1, 2010 through June 30, 2011

Fred reported that an additional written report on the previous month's finances would be distributed after the meeting.

An annual budget of \$12,500 was proposed for Fiscal year 2011-2012. The committee will consider the proposed budget at the August meeting. There was a discussion of dues and a possible increase, the cost of notices and solicitations for events, and how to track budget vs. actual expenses. The committee agreed in principle to raise dues and that a further discussion of dues increases would be included in the August meeting.

The Treasurer's report was accepted unanimously.

4. Schools Committee

Progress has been made on expanding the committee as five or six new members have emerged recently. The goal for the next academic year is to identify enough interviewers to be able to interview every applicant

5. Events Committee

Global Night of Networking:

Took place June 21 at Chopper's Sports Grill in Denver (Cherry Creek North) and Jill's Bar at the St. Julien Hotel in Boulder. Additional structure to the event yielded a stronger ability of participants to find key people with whom to network. The addition of sign-in sheets which included a question concerning reasons members sought to attend the event was collected and then distributed to attendees. Approximately 70 individuals were in attendance.

June Aspen Event:

About 90 people attended the Aaron Harbor TV show recording session of interviews with Supreme Court justices in Aspen. There were a lot of Harvard people and possibly half of the group of attendees were associated with the Ivy League.

2011 Summer Picnic:

The picnic will be August 28 at the home of Mr.Ted Hallaby in Cherry Hills. Volunteers are needed for the event. Steering committee members are encouraged to participate and volunteer.

Monthly Speaker Series:

Babette will email Steering Committee members some information later this week about the proposed Andrew Romanoff talk on August 15.

Recognition Dinner:

Work is underway to secure a location for the proposed dinner in September. Diana has worked with the Spire staff to schedule an evening in a function room there. The space is provided without cost if the Spire may contact attendees to solicit a tour of the building. Concerns were held about privacy protection for attendees and the potential for negative impacts on people who we are trying to recognize. Fred suggested the Steering Committee offer to the Spire to mail (on the Spire's behalf) information to our attendees. Diana will ask the Spire about this. Anna has ideas for other locations for Diana.
